



2021-2022 Health and Safety Plan Summary:

Moon Area School District students will attend school daily in a traditional setting with safety measures in place. We want our community to know that we are committed to providing a safe and healthy learning environment for all students and staff. Therefore, we will continue to take steps to prevent and mitigate the transmission of the COVID-19 virus on our campuses by adhering to current state and local mandates and recommendations. The purpose of this document is to inform the community that students and staff will return to a traditional learning model with the following plans to maintain a healthy and safe environment. This plan is also subject to change in response to any future health and safety needs that may arise throughout the year.

- 1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?*

Starting with the 2021-2022 school year, Moon Area School District students will attend school daily, Monday through Friday, in a traditional setting with safety measures in place. We will continue to take steps to mitigate the transmission of the COVID-19 virus on our campuses by following the guidance of state and local officials. During the 2020-2021 school year, many changes were made in the cleaning and sanitation protocols to disinfect our schools frequently throughout the day. These enhancements will remain in effect and are described in more detail below.

Additionally, MASD will monitor the COVID-19 risk level in the surrounding areas and adjust plans when necessary to ensure safety. At this time, MASD is confident that it can safely resume a traditional, daily, in-person learning model while following all safety and health guidelines to the maximum extent feasible. Recommended social distancing guidelines will continue to be followed to the greatest extent possible. The District will also follow recommendations to isolate students who present symptoms of the virus and perform contact tracing procedures when necessary.



- 2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?*

The Moon Area School District will ensure continuity of services for all students through a daily, traditional in-person learning model. Students who need to remain in a fully remote learning setting may enroll in the Moon Area Cyber School program, which provides asynchronous access to a full online curriculum where students may work independently to earn credits to complete grade level and graduation requirements.

Student learning growth will be monitored with to identify and address the learning needs of students.

Academic Needs, Materials, and Supplies

Students in grades K-4 will be provided with their own iPads, and students in grades 5-12 will be provided laptops. The District issued devices will be used as much as possible with online resources to limit the sharing of materials and supplies. Schools will continue use of Office 365, including Microsoft Teams, to house the bulk of instructional materials and collaborative learning tools. School supplies and paper handouts may also be provided to students. Some supplies and equipment may be shared when necessary following a sanitation protocol, which includes wiping supplies and equipment with an approved disinfectant in between uses and having students use hand sanitizer before and afterward.

Health Screenings & Needs

The first line of defense in keeping our school environments healthy begins at home. Families are asked to continue to monitor their child(ren) for symptoms of illness. Any student who has a fever or is experiencing other symptoms related to illness are not permitted to attend school until they are symptom free for 24 hours without medication or are cleared by a medical professional.

- Parents/guardians should report to the school administrator any possible COVID-19 exposure.
- Each building has a designated area for holding students who become sick at school.
- Parents/guardians will be called to pick up a student who is experiencing symptoms.



- Contact tracing protocols will remain in place. Contact tracing of individuals with COVID-19 will be discussed with the family, county, and state health department when appropriate
- Students who must be quarantined due to contact tracing will have the opportunity to make up missed work through communication with teachers using Microsoft Teams and other approved technology platforms.
- An infected individual must submit a negative testing report or report from their doctor stating that they are healthy and can return to work/school after appropriate quarantine.

Food Service

Cafeteria service will be open to students and staff for breakfast and lunch. Food items will be provided in a “Grab and Go” manner where portions are provided in containers with lids when appropriate. For example, there will not be an open self-serve salad bar. Instead, salads will be pre-made and packaged in a container to Grab and Go. This will minimize the handling of food items and utensils by different people while choosing meal items.

Students will not have to enter PIN numbers this year at the cafeteria because breakfast and lunch is free to all students for the entire 2021-2022 school year. This reduces the potential spread of germs from using a shared keypad to acquire meals.

Meals to Go will be available for all students attending the Moon Area Cyber School program. Students who are under mandatory quarantine may also participate in the Meals to Go program for the duration of their quarantine. Families may pick up packaged breakfast and lunch meals on a weekly basis.

Counseling and Other Health Services

To provide for the social, emotional, and mental health needs that students may have upon their return to a traditional model of instruction, school nurses, counselors, and other specialized staff will be available to discuss student needs with families with a commitment to ensuring that the well-being of all students can be met.

Monitoring COVID-19 Risk

The Superintendent regularly attends meetings with county and state health officials. Should community risk levels increase to a point where it is no longer deemed safe to conduct school in-person during the 2021-2022 school year, the District deliver instructional services in a remote environment. Should the District or a school building need to shift to a remote learning environment, families will be informed about the nature



of the instructional model containing all necessary details.

<p>a. Universal and correct wearing of masks;</p>	<p>Face coverings are currently mandatory for staff and students while in school facilities and on school transportation. At this time, face coverings are not needed outside when social distancing is in place. However, students participating in extra-curricular activities and sports are encouraged to wear face coverings when possible. Students are responsible for supplying their own face covers, but each school has a limited supply of face covers to provide students in the event one is needed.</p>
<p>b. Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding);</p>	<p>Social distancing will be practiced to the greatest extent possible, following the recommendation to physically distance classroom desks and furniture to be at least 3 feet apart. Students will respect the 3 feet apart protocol while waiting in lines or walking in the hallways. Visual reminders are posted within the school at key areas and verbal reminders will be communicated by staff.</p> <p>Upon arrival to school, students will proceed directly to their designated classrooms. This will eliminate congested holding areas before school begins.</p>

	<p>Student arrival times will be communicated by each building administrator.</p> <p>Plexiglass barriers have been installed in office areas where contact with others frequently occurs.</p> <p>Student use of lockers will be limited. Students are expected to plan accordingly to ensure they have needed materials for each class.</p> <p>Visitors and volunteers in the schools will be limited. All approved visitors and volunteers will be required to wear face coverings.</p>
<p>c. Handwashing and respiratory etiquette;</p>	<p>Each classroom is equipped with the necessary sanitation supplies including hand sanitizer stations, paper towels, spray bottles containing approved disinfectant, soap, and trash cans. Students are encouraged to clean their hands upon entering and exiting classrooms. Supplies are restocked nightly or when needed.</p> <p>Additional hand sanitizing stations and hygiene reminders are present throughout all schools at strategic locations to promote cleanliness.</p> <p>Nurses provide ongoing training to students, staff, and families on best practices for wellness and personal hygiene.</p>

<p>d. Cleaning and maintaining healthy facilities, including improving ventilation;</p>	<p>Custodial staff will continue to clean all areas daily with disinfectant that has been approved for school buildings and COVID-19.</p> <p>Commonly touched surfaces such as handrails, elevator buttons, door handles, etc., will be sanitized regularly throughout the school day.</p> <p>After students and staff leave for the day, a thorough cleaning is completed in all classrooms, bathrooms, hallways, lockers, offices, and other rooms including the library, gymnasium, and cafeteria. Floors are also cleaned each night. Each school has its own electrostatic sprayer to sanitize the premises overnight.</p> <p>Maintenance staff will ensure ventilation is properly maintained in all buildings. High efficiency MERV-13 filters are used and checked routinely to make sure they are cleaned and replaced when necessary.</p> <p>Air quality will be measured, and fresh air will be circulated throughout the system to ensure proper ventilation.</p> <p>HVAC systems run throughout the night to allow for multiple exchanges to clear out remaining airborne particles and pathogens.</p>

<p>e. Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;</p>	<p>Each building has a designated area for holding if a student becomes ill at school. This area is separated from the areas used to service students and staff who are well.</p> <p>Parents/guardians will be called to pick up a student that is experiencing symptoms.</p> <p>Contract tracing of individuals with COVID-19 will be discussed with the family, county, and state health department when appropriate.</p> <p>The District and/or school will communicate with the family throughout exposure.</p>
<p>f. Diagnostic and screening testing;</p>	<p>Parents/guardians and staff should monitor their temperatures and physical wellness each day before coming to school or work. All must report to the school administration any possible COVID-19 exposure.</p> <p>Individuals who have been infected or have been determined to be a close contact of someone who is infected, must remain at home in quarantine.</p> <p>An infected individual must submit a negative testing report or report from their doctor stating that they are healthy and can return to work/school after appropriate quarantine.</p>
<p>g. Efforts to provide vaccinations to school communities;</p>	<p>The District has already participated in a vaccination clinic in the spring of 2021 and values its partnerships with local</p>

	<p>pharmacies to serve the community. Future vaccination clinics may be held for school communities as needed. It is noted that there are many local pharmacies, doctor’s offices, and health clinics that currently offer the COVID-19 vaccine to all who are eligible.</p>
<p>h. Appropriate accommodations for students with disabilities with respect to health and safety policies; and</p>	<p>Appropriate accommodations will be made for students with disabilities as indicated through the IEP or 504 Plan review and revision processes.</p>
<p>i. Coordination with state and local health officials.</p>	<p>The Superintendent attends regular meetings with state and local health officials along with other superintendents to stay current with information and collaborate with other districts on planning efforts. Nurses and health staff are regularly involved in communications and planning with regard to ensuring that the recommended protocols are followed.</p>
